### Description:

Universitas Indonesia strives to help teaching staff and employees to be able to have decent housing. In order to support that purpose, UI issues recommendation letters for teaching staff and employees planning to propose home ownership credit to financial institutions so they can afford a decent home. Partnering with several banks, apartment developers, and cooperatives, the university aims to enable its employees to choose between competitive prices. Aside from that, several public banks also facilitate home ownership credit to teaching staff. Additionally, the regional government (e.g. the government of DKI Jakarta) exempts teachers and lecturers from land and property tax. Previously UI has some housing complexes for lectures such as in Rawamangun and Ciputat Area.
